### **Purpose Built Student Accommodation**

## What is Purpose Built Student Accommodation?

Purpose Built Student Accommodation (PBSA) is housing specifically built for students by private developers. This includes halls of residence and accommodation owned by a private provider (the property let must include at least 30 bedrooms).

#### What type of tenancy do I have?

If you are living in PBSA, you will most likely have a Common Law Tenancy. This means that you have a tenancy which is not covered by a specific piece of legislation passed by parliament. Instead, your rights come from decisions made by courts going back many years.



If you rent a property which is not PBSA and do not live with your landlord, then it is likely that you have a Private Residential Tenancy (PRT). You can refer to our separate PRT fact sheet for more information on your rights.

If you are insure of what type of tenancy you have, you can use <u>Shelter Scotland's</u> <u>free tenancy checker tool.</u>

# Are my rights different during the COVID-19 pandemic?

This year the Scottish Parliament passed The Coronavirus (Scotland) Act (No.2) which has introduced temporary changes to notice periods for those students in PBSA who want to end their tenancy because of the coronavirus outbreak. These are **statutory** changes, which means they override what is written in your common law tenancy agreement.

#### What are the changes?

- If you were living in a tenancy before 27 May 2020, you can give 7 days' notice to end your tenancy
- In all other cases, you can give 28 days' notice to end your tenancy

#### How do I make sure my notice is valid?

For your notice to be considered valid, it must be:

- In writing, which includes electronic communications
- Your notice must state the day on which the tenancy is to end. This means you need to state the day after the last day of the minimum notice period.

Top tip! If you send your notice electronically (for example email), include a request for 'read receipt' to make sure the notice is received. If you send a physical copy, you can use recorded delivery.



#### How long will these changes affect me?

The Coronavirus (Scotland) Act (No.2 came into force on 27 May 2020 and is due to expire on 31 March 2021.
